If you refuse to call this meeting, written notice is hereby given that a special closed meeting of the Missouri State Board of Education has been called by Board Members Claudia Onate Greim, Eddy Justice, and Doug Russell, and will be held on November 21, 2017 at 10:00AM in the Board of Education Conference Room on the first floor of the Jefferson Building at 205 Jefferson St., Jefferson City, MO 65101 (RSMo 161.072) to consider the following:

1. Hiring, firing, disciplining or promoting of employees of the Department of Elementary and Secondary Education and general personnel and structural considerations.

Please direct the Executive Assistant to prepare, post and make available to the news media notice of such closed meeting, notice of the closed record, and closed vote in the manner and time as required by law, and that a copy of the notice be filed with the minutes of the meeting it announces. As has been the case in prior meetings of this body, members who cannot attend in person will be allowed to attend by phone with full privileges of attendance and membership. It is expected that the rules of this closed session as prescribed by Roberts Rules of Order Newly Revised 11th Edition will be followed, specifically illustrated on page 96, Lines 6-17.

About the State Board of Education:

MISSOURI ASSOCIATION FOR COLLEGES OF TEACHER EDUCATION

The State Board of Education is made up of eight citizens appointed by the Governor and confirmed by the Senate. Members serve staggered, eight-year terms so that one term expires each year. However, when terms expire, members continue to serve until being replaced or reappointed. No more than four members of the State Board may belong to the same political party and no more than one member may reside in the same county or congressional district. Besides the appointment of the commissioner, the State Board has other important duties including the establishment of content matrices for educator preparation programs throughout the state and assessment requirements for the Annual Performance Report for educator preparation programs. It also accredits all educator preparation programs.
